I am liable for punishment according to clause 9.1 of the Regulations / Directive/Ordinance of AIIMS Madurai, without prejudice to any other criminal action that may be taken against me under any penal law

or any law for the time being in force and for which I will be solely responsible and shall not claim any compensation whatsoever from AIIMS Madurai or its office bearers.
