The candidature of the provisionally eligible candidates (listed in Annexure 2) for the interview will be subject to submission of the requisite certificate(s)/document(s) mentioned against his/her name on the day of interview during certificate verification. Failure to submit the requisite certificate(s)/document(s), the candidate will not be allowed to appear for the interview.

The eligibility of the candidate at this stage is purely provisional and the candidate being merely adjudged as Eligible/Provisionally eligible does not confer any right on him/her being selected for the post. If at any time during the selection process, it comes to the notice that a candidate has filled wrong entries/does not possess the required qualification as per the Recruitment Rules for the concerned post(s), he/she will be treated/declared as Not eligible and his/her candidature will be treated as cancelled.
