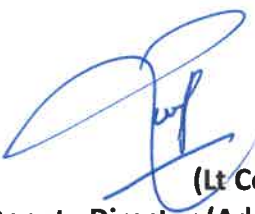
3. **Proof of payment of online receipt (SBI Collect Receipt), if applicable.**
4. The Candidate should bring the following **original documents along with the duly filled in application form** and one set of self-attested photocopies at the time of interview at the Institute (to be arranged in the following order):
  - a) Proof of Date of Birth (SSLC or Birth Certificate).
  - b) SSLC Certificate.
  - c) HSC Certificate.
  - d) MBBS Mark Sheets (All Semester).
  - e) MBBS Degree / Provisional Certificate.
  - f) Internship Completion Certificate.
  - g) Attempt Certificate.
  - h) Valid MCI / NMC / DCI / State Council Registration.
  - i) Valid SC / ST / OBC / PwD / EWS Certificate issued by the competent authority (if applicable).
  - j) Experience Certificate (if any).
  - k) No Objection Certificate (if applicable).
  - l) Identity Proof (PAN Card / Aadhar Card / Passport).
  - m) Address Proof (Aadhar Card).
  - n) Two recent passport size photographs.
  - o) FMGE Certificate conducted by NBE (For Foreign Graduate).
  - p) Copies of any other relevant documents, if required.
5. **Certificate of Registration** with National Medical Commission / State Medical Council as the case may be (updated and must be valid as on date).

**IMPORTANT INSTRUCTIONS :**

- ✓ Candidates have been called for the written test subject to the fulfilment of all the aforesaid requirements as asked for, failing which candidates will not be allowed to appear for the written test / interview under any circumstances.
- ✓ If at any stage, it is found that candidates are not fulfilling the eligibility criteria for the post or any declaration given or information furnished proves to be false or if they are found to have wilfully suppressed any material information, they shall be removed from service and any other action as deemed necessary by the Institute may be initiated.

- ✓ No TA / DA will be paid for attending written test / interview.
- ✓ **Request for change of date, time, venue, etc will not be entertained.**
