With reference to the subject cited above, the pre-bid meeting was conducted through hybrid mode and the following clarification sought by the bidders. The clarification is submitted below :

S. No	Query	Reply
1.	Whether tender documents shall be submitted in GeM Portal or any other mode is permissible ?	The tenders should be submitted CPPP only.
2.	Whether the 7 Seater Car can be specified clearly for submitting the quote	Innova – Crysta
3.	Whether the 4 Seater Car can be specified clearly for submitting the quote	Honda City / Maruti Ciaz / Toyota Etios / Swift Dezire / Honda Amaze
4.	How the mileage will be calculated for billing ?	From AIIMS Madurai to AIIMS Madurai
5.	Whether the parking facility is available at the Institute campus ?	Cars can be parked at the institute premises i.e. Project Cell Office, Thoppur, Madurai
6.	Whether the allotted car shall be used for any other purposes ?	The allotted cars for AIIMS Madurai should not be used for other clients / other usages.
7.	Whether white board car can be provided ?	As per the tender terms and conditions, all the vehicles should be commercial registration only.
8.	Whether the seating capacity of bus is 56 ?	The seating capacity of bus shall be minimum 50 to 52.
9.	Any preference for deployment of helper i.e. Male / Female ?	Helper is not required. The hiring charges shall be quoted accordingly.
10.	Whether the GST is applicable 5% or 18% ?	Applicable GST is 5%.
11.	Whether the EMD exemption is permissible ?	Yes. The category of services should be matched with the tender terms and conditions.
12.	Whether the Performance Security Deposit Exemption is permissible ?	No. The performance security deposit should be paid by the L-1 bidder as per the conditions of the tender.

The due date for submission of bids will be extended as per rule. Kindly check the CPPP for further update, if any.
