ADMISSION PROCESS

The counselling for admission to MBBS courses in AIIMS Madurai campus will be conducted by the Medical Counselling Committee (MCC), Directorate General of Health Services, Ministry of Health and Family Welfare, Government of India based on the NTA NEET 2024 All-India scores.

The candidates along with their Parents / Guardian should report in person to the following address for the admission process by 09:15 AM

Admissions to the MBBS course are subject to the verification of certificates and medical examination and payment of fees on reporting for admission at AIIMS Madurai.

The candidates should bring the following at the time of admission within the stipulated time period, failing which, admission will be denied:

- All the certificates in original (as given in the list below)
- One set of self-attested photocopies of all the certificates
- Six Passport size recent color photographs

List of certificates to be submitted at the time of admission:

- 1. Identity proof (as mentioned in the NTA NEET 2024 Information Bulletin Aadhar card).
- 2. Admit Cards of Exam issued by NTA.
- 3. Result/ Rank letter issued by NTA.
- 4. Provisional allotment letter generated on-line.
- 5. Proof of Date of Birth (Birth Certificate or X Std. Certificate).
- 6. Pass Certificate of the qualifying examination.
- 7. Statement of marks of the qualifying examination.
- 8. Character and Conduct Certificate from the Head of the Institute last studied.
- 9. In case of Other Backward Classes/ Scheduled Caste/ Scheduled Tribe, a Community Certificate, recently obtained from the competent authority (as mentioned in the NTA NEET 2024 Information Bulletin)
- 10. Economically Weaker Sections (EWSs) candidates should produce the required Income& Asset Certificate as (as mentioned in the NTA NEET 2024 Information Bulletin)

- 11. Transfer Certificate / Migration Certificate from the Head of the Institution last studied.
 Note: Please verify that the student's name is consistent across all original certificates.
 Any discrepancies must be accompanied by proper explanation and supporting documentation from your side.
- 12. Medical Certificate from the authorized centers as listed in the NTA NEET 2024 Information Bulletin in case of PwBD Candidate.
- 13. <u>1st dose of Hepatitis B vaccination certificate.</u> (Please ensure that the name, designation, and registration number of the medical officer signing the document are clearly stated)
- 14. Take printout of the affidavits and undertakings as uploaded in the AIIMS Madurai Website and sign and bring the documents
 - Anti ragging undertaking by parent and student.
 - Substance abuse undertaking.
 - · Hostel rules and regulations undertaking
 - ID card application
 - Student code of conduct and honor code

Important Note:

- OBC-NCL, EWS, PwBD certificates should be same as that submitted to NEET exam.
- If the certificates are in a language other than English, an English translation of the certificate attested by a Gazette Officer should be produced. Failure will lead to delay in admission process.
- Please verify that the student's name is consistent across all original certificates. To correct the discrepancies is the responsibility of the student
- Failure to produce any of the required certificates in the original and their photocopies during verification will lead to forfeiture of the allotted seat. No additional time or opportunity will be provided for producing the certificates.

- After the admission process is complete, the student's original certificates will be retained by AIIMS Madurai. These will be returned in person if the student is allotted another institute in subsequent counselling. If the student continues with AIIMS Madurai, the certificates will only be returned at the end of the course.
- If a candidate is withdrawing his / her seat before or after issue of the admission order, a penalty of Rs.10,000/- (Rupees ten thousand only) will be imposed and fees paid will not be refunded, unless he / she is found medically disqualified.
- If a candidate who joined MBBS course, leaves the said course in between, shall be liable to pay a sum of Rs.5000/- (Rupees Five Thousand only) by way of compensation / losses incurred by the AIIMS due to such midstream departure.

All candidates should report within the time period mentioned in their 'allotment letter', failing which, they will forfeit the right to admission. At any time, if the competent authorities find that admission was sought based on false/incorrect information/documents and suppression of relevant facts, educational qualification or quota, the admission offered or the admission already completed shall be cancelled, irrespective of the stage of study of that course. Further, legal proceedings will also be initiated against such candidates for such action/(s). Hence, candidates are warned against indulging in such action(s), in their own interest. All parents are also requested to make note of the above provision, and take due care and diligence, in all matters concerning admission to the courses.

ADMISSIONS TO THE MBBS COURSE SHALL BE REJECTED IN THE FOLLOWING SITUATIONS (including but not limited to):

- 1. Candidates who fail to fulfil the prescribed age limit criteria as per NTA NEET 2024 Information Bulletin.
- 2. Candidates who fail to obtain the minimum stipulated marks in the qualifying examination (as mentioned in the NTA NEET 2024 Information Bulletin).
- 3. Candidates who have applied under Non-Creamy Layer OBC Category and whose subcaste is NOT listed in the current Central OBC List and whose certificate has NOT been submitted in the prescribed format from the Competent Authority.
- 4. The candidates who have applied under SC/ST Category WITHOUT valid Certificate as in the prescribed format from the Competent Authority.

Presence of the parents or the guardian is must for completion of the admission process.

Fees & Other Payments

The following fees should be paid by the candidates through **Demand Draft taken in favour of "AIIMS Madurai" payable at Puducherry** once you are deemed medically fit by the Medical Board of the Institute. Fee once paid will **NOT** be refunded under any circumstances.

Note: To ensure a smooth admission process, please secure a Demand Draft (DD) from a bank in your location prior to your arrival for the admission procedure.

Fees are subject to revision. Fees paid are for the entire course.

The above payment is to be made through Demand Draft separately for Academic (Rs.1,628/-) and hostel (Rs.4,228/-). Please note that online, Cards, Cheques, etc. will not be accepted under any circumstances.

Other annual fee, Examination fees and mess food fees structure will be intimated later.

HOSTEL FACILITIES

- 1. All students can avail a common hostel accommodation subject to availability.
- 2. Separate Hostels are available for boys and girls.
- 3. Hostel Accommodation is meant for outstation candidates.
- 4. Application for accommodation in the hostels should be in the prescribed form along with the assurance by the parent or guardian for the good conduct and behavior of the candidate during his/her stay in the hostel. Allotment of the hostel will be on first-cum-first-serve basis.
- 5. The hostel fee structure is as detailed above in the table.
- 6. Each student residing in the hostel has to pay a caution deposit of Rs. 1,000/-, which will be refunded after making deductions, if any, at the time of vacating the hostel room.
- 7. Mess facilities are available. A security deposit of Rs.500/- should be paid towards advance. **Mess food fee will be informed on a later date.**
- 8. If a student is found occupying a hostel room but staying elsewhere, the room allotment will be forfeited and a suitable penalty will be levied on the student.

Annual payment / Charges for accommodation. Charges will not be refunded, when the student is evicted from the hostel in between.

Delay in payment of Academic / hostel fees will attract fine and hall ticket for the subsequent Professional examination will be withheld.

GENERAL RULES AND REGULATIONS

Conduct and Discipline

Students shall conform to a high standard of discipline and shall conduct themselves, within and outside the precincts of the Institute. She/he shall have the seriousness of purpose and shall in every way, train himself to a life of earnest endeavour and co-operation. He/she shall follow strict ethical standards. He/she shall show due courtesy and consideration to the employees of the Institute and Hostels, to his/her fellow students, respect to the wardens of the hostel and the teachers of the Institute and pay due attention and courtesy to visitors and patients in the attached hospital divisions of this seat of Medical Learning.

Honour code

In order to promote ethical behaviour, AIIMS Madurai requires every student to agree to abide by the Honour Code. At the time of admission, every student has to sign the Honour Code. Violations of this code are taken very seriously and may result in suspension or expulsion. Admission will be withheld if the Honour Code applicable to Institute and Hospital related activities is not duly signed and submitted at the time of admission with a copy to the respective department.

Ragging is banned

Ragging is banned in AIIMS Madurai. If a student is found to have indulged in ragging in the past, or if it is noticed later that he/she has indulged in ragging, then he/she may be expelled from the Institute.

Supreme Court Ruling regarding Ragging

As per direction of the Hon'ble Supreme Court of India, the Government has banned ragging completely in any form inside and outside the campus and all the AIIMS Madurai authorities are determined not to allow any form of ragging. Whosoever directly or indirectly commits, participates in, abets or instigates ragging within or outside any of the AIIMS Madurai shall an FIR lodged against him/her and he/she will be suspended or rusticated from the institution and shall also be liable to be fined which may extend to **Rs.10,000/-.** In case the applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he/she has indulged in ragging, admission can be refused or he/ she shall be expelled from the educational institution.

The punishment may also include suspension from attending the classes withholding/withdrawing fellowship/scholarship and other financial benefits or withholding the result.

Legal issues

- 1. Those candidates indulging in impersonation or illegal means of obtaining admission to AIIMS Madurai shall be liable to prosecution under the Indian Penal Code.
- 2. The disputes, if any with regard to the admission process will be subject to the legal Jurisdiction of the Madurai High Court.

- 1. AIIMS Madurai reserves the right to make changes in the information provided in this Prospectus based on the directives from the competent authority & Government of India. This cannot be quoted for any sanction.
